



KOSSUTH COUNTY REPUBLICAN CENTRAL COMMITTEE MEETING MINUTES

The Kossuth County Republican Central Committee met Monday, April 26, 2021, at the Thul Shed, with 23 people in attendance. Kyle Stecker offered a motion that Dr. Brent Owen serve on the Central Committee for his precinct, Wendell Steven seconded the motion and it passed.

RESOLUTION

Black Hawk County Republican Committee Resolution about Senator Mitch McConnell

Where as, President Donald J. Trump received more votes in the 2020 election than any other Republican candidate in Black Hawk County.

Where as, President Donald J. Trump received more votes than any other Republican candidate in Iowa in the 2020 elections.

Where as, Donald J. Trump received more votes as a sitting president than any previous sitting president in American history.

And since his nomination by the Republican Party for the U.S. presidency, President Donald J. Trump has been and still is the recognized leader of the Republican Party.

The following statements were made by Senator Mitch McConnell on February 13 on the floor of the Senate:

“There is no question, none, that President Trump is practically and morally responsible for provoking the events of that day (January 6).”

First, the Black Hawk County Republicans do not believe that President Trump “provoked” the capitol incursion nor do we believe that he was “practically and morally responsible.”

Continuing on the floor of the Senate on February 13, Senator McConnell said:

“President Trump is still liable for everything he did while in office, as an ordinary citizen, unless the statute of limitations has run, still liable for everything he did while in office, didn’t get away with anything yet – yet”

Senator Mitch McConnell is encouraging criminal charges against Donald J. Trump who has been acquitted from impeachment times two.

In the same address, Senator McConnell slandered President Trump several times and impinged on the integrity of representatives who voted against the impeachment. President Trump clearly remains on the moral high ground and is still leader of the Republican Party.

The Black Hawk County Republicans join the 75 million citizens who voted for President Donald J. Trump to ensure that he is the indisputable leader of the Republican Party and not Senator McConnell.

Be it resolved that Mitch McConnell does not represent the values of Republican voters in Black Hawk County and therefore unfit to be the Republican leader of the U.S. Senate. Furthermore, we respectfully request Senator Grassley and Senator Ernst to initiate and support every effort to remove Senator McConnell from his position. We submit this resolution to the first district executive committee for consideration and approval by that body.
