Kossuth County GOP Proposed Planks for 2016 Platform

Preamble: The Kossuth County Republicans hereby adopt and approve this platform. It articulates our beliefs and provides a guide for our elected representatives and nominees in putting our beliefs into effect.

Economy, Taxation and Budget

- 1. We support a balanced budget amendment and believe that the State of Iowa and the Federal Government should maintain a balanced budget by controlling spending and that the national debt should be reduced and ultimately paid in full.
- 2. We support that earmarked legislation should be eliminated.
- 3. We resist government distortion of the free market through subsidies and bailouts.
- 4. We should audit the Federal Reserve system.
- 5. We should work to strengthen the United States dollar by returning to the gold standard.
- 6. We should stop giving money to foreign countries unless they are friendly and work with us. .
- 7. We support ending Baseline budgeting
- 8. We support lower taxation and simplification of the tax code.
- 9. We support removing the Death tax and lowering of corporation taxes.

Education

- 10. We support the abolition of the U.S Department of Education with return of educational support and monitoring of all levels of education to each state.
- 11. We support the display of the American flag in public school classrooms and daily recitation of the Pledge of Allegiance.
- 12. We believe preschool programs should be optional.
- 13. We support that public school educators stress sexual abstinence outside of marriage to prevent unwanted pregnancies, sexually transmitted diseases, and related psychological problems.
- 14. Public school education should be confined to the development of academic and critical thinking skills, and should not be focused on promoting lifestyle and social agendas.
- 15. We believe that teachers' salaries should be based on performance rather than solely on tenure. We support programs that reward superior teachers and outline procedures that eliminate ineffective educators.
- 16. In order to protect the integrity of research being conducted in higher education, faculty should be allowed to continue to work toward and attain tenure.
- 17. We support the repeal of common core

Energy and Environment

- 18. We support the building of nuclear power plants, off-shore drilling, and energy refineries in the United States with safeguards for environmental protection without the use of government subsidies.
- 19. We support construction of pipelines to increase oil availability and energy independence as long as it does not violate personal rights.
- 20. We support the promotion of the natural gas and coal industry and relaxation of current oppressive restrictions.

Agriculture

21. The USEPA should not be allowed to have regulatory jurisdiction under the Clean Water Act of regularly cropped but seasonally wet agricultural land.

- 22. The USDA should require no more than the mitigation of lost wetland functions in the conversion of farmed wetland under the farm program. Acreage replacement is excessive mitigation.
- 23. The endangered species act should be amended to take into account and mitigate adverse impacts upon people and their communities.
- 24. State water quality standards must promote the wise development and use of our abundant resources and not serve the agenda of environmental extremists.
- 25. We oppose legislation requiring open pen hog farming.

Government and elections

- 26. We believe that the federal government should follow the US Constitution and adhere to its founding principles.
- 27. We believe that the government should honor its commitments to our military personnel and veterans.
- 28. We are committed to the principle of federalism in that families, city, county, and state governments have certain powers and responsibilities before the federal government.
- 29. Iowa Delegates to the National Convention are urged NOT to vote for any candidate that was not one of the original candidates running during the Iowa Caucus.
- 30. We believe that the US Congress should be strictly limited to the 18 enumerated powers in the United States Constitution and that all others should be left to the states and to the people in accordance with the 10th Amendment.
- 31. We propose that the Iowa General Assembly enact legislation that seeks to reestablish the proper relationship between the State of Iowa and the federal government, as defined by the 10th Amendment to the United States Constitution.
- 32. We support requiring candidates for state and federal offices in the state of Iowa to provide proof of citizenship by providing a "state government issued birth certificate with a raised seal".
- 33. We believe that all items to be voted upon by any government body should be posted online 120 hours prior to their vote.
- 34. We believe in open and transparent government that is accessible and accountable to ordinary citizens and citizen-based organizations.
- 35. We believe that the budgeting process of the State of Iowa should be more open and transparent so that citizens have the opportunity to scrutinize individual line items.
- 36. We believe that we should reduce the size and scope of the state and federal governments.
- 37. We believe that only citizens bearing proper voter ID should be allowed to vote and that proof of citizenship should be required for absentee voting.
- 38. We believe the federal government through legislation should reduce the undue burdens placed on domestic enterprise through rulings of the EPA.
- 39. We support requesting a convention of states for the purpose of curbing the federal governments abuses of power.
- 40. We support term limits at state and federal levels
- 41. We believe that Congress must not exempt themselves or the President from laws that they pass.
- 42. We believe that any bill that is passed in the House shall be debated on the floor of the full Senate.
- 43. Be it resolved that the legislature must approve the Governor's appointments to the Iowa Utilities Board and increase the number of members on the Board.
- 44. We support Eminent Domain for the public welfare
- 45. We oppose the abuse of Eminent Domain for private companies and/or entities for their profits at the expense of property owners and their constitutional rights.
- 46. We support renewable energy.

Guns

47. We support the adoption of the following amendment to the Iowa Constitution: "The right of the people to keep and bear arms shall not be infringed".

- 48. We support Iowa adopting the Stand Your Ground law.
- 49. We support the Second Amendment to the Constitution and recognize the right of individuals to bear arms.
- 50. We support enforcement of current gun laws rather than creating additional legislation to reduce crime.

Healthcare

- 51. We oppose the nationalization of the health care system.
- 52. We support the "Conscience Clause" laws designed to protect healthcare professionals who, for moral or religious reasons, refuse to provide services such as abortion or birth control.
- 53. We strongly oppose Obamacare and demand its immediate repeal!

Immigration

- 54. We believe only United States citizens and legal immigrants are entitled to Constitutional protections and government services.
- 55. We believe that for the safety, security, and economic stability of the United States, that stopping the influx of illegal immigrants is a top priority. A first step is to secure the border and enforce the laws that are already in place.
- 56. We believe the federal government should stop supporting illegal immigration.
- 57. We encourage legal immigration and support efficient processing of applications.
- 58. We support cooperation among local, state, and federal agencies in identifying and processing illegal immigrants.
- 59. We support the worker-visa program to allow legal immigrants to work in the United States.
- 60. We believe that employers who hire illegal immigrants/undocumented workers should be fined heavily as provided by current law.
- 61. We believe English should be the official language of the United States.
- 62. We believe that only citizens and legal residents of the United States should be eligible to obtain a drivers license.

International Trade

63. We support trade policies which provide fair opportunity to American producers

Judicial

- 64. We strongly oppose judicial activism and call upon judges at all levels to adhere, strictly, to the original intent of the United States Constitution and their respective state constitutions.
- 65. We support appointment of judges who adhere strictly to the original intent of the US Constitution, support the sanctity of innocent human life, and honor family values.
- 66. We should impeach judges who willfully create or change legislation from the bench.
- 67. We support efforts to eliminate frivolous lawsuits and cap liability.
- 68. We assert that the Constitution of the United States is the highest law of the land. International law, treaties or agreements cannot be used as the basis of court decisions in the United States of America.

Life

- 69. We believe human life is a sacred gift from our Creator and is a fundamental right as is outlined in the Constitution and the Declaration of Independence. This includes the unborn beginning at conception, the elderly, the chronically or terminally ill, and the physically and mentally handicapped. No human life should ever be diminished or arbitrarily taken from conception to natural death.
- 70. We support the reversal of Roe v. Wade and returning the regulatory authority to the states.
- 71. We support legislation requiring consent by parent and/or legal guardian before a minor child or ward receives an abortion or any other reproductive services or products.

- 72. We oppose using public revenues to fund abortions or for organizations, such as Planned Parenthood, which advocate abortion.
- 73. We support a ban on all forms of abortion
- 74. We oppose trafficking in fetal parts and tissue collected from abortion procedures

Media

75. We oppose the "Fairness Doctrine" regulating free speech on the radio.

National Security

- 76. We believe that a strong military is imperative to the safety and security of the United States and that rebuilding our military is crucial to our national security
- 77. We believe that the Department of Homeland Security should be adequately funded and should teach citizens what they can do individually to fight against terror.
- 78. We believe that trials of foreign terrorists, born or residing outside of the United States at the time of an attack, be tried in military rather than civil courts.
- 79. We believe that the United States and Israel should remain strong allies.

Marriage

- 80. We support a constitutional amendment defining marriage as a union between one man and one woman.
- 81. The Iowa legislature should allow a vote of the people on a constitutional amendment barring gay marriage.

Personal Rights and Responsibilities

- 82. We oppose granting special rights to groups of people based on race, sexual practices, or creed through "hate crimes" legislation.
- 83. We believe that equal opportunity is important but that equal outcomes cannot and should not be guaranteed by any government as it infringes upon freedom.
- 84. We affirm that homosexuality is a type of behavior rather than a type of person.

Religious Freedom

- 85. We support the First Amendment to the Constitution: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof.
- 86. We believe the phrase "in God we trust" stamped on our currency is consistent with the Constitution of the United States of America.
- 87. We do not oppose the placement of religious symbols on public property.
- 88. We believe that the Constitution provides the freedom to allow prayer openly in public schools.
- 89. We affirm an individual's right to refrain from any practice in his/her business that would go against their religious convictions.
- 90. We oppose banning the display of the Ten Commandments by state and federal government.

Right to Work

91. We support Iowa's "Right to Work" law and oppose "Fair Share" legislation.

Social Security & Entitlements

- 92. We support preserving Social Security and Medicare for those receiving benefits and to those who have contributed to the Social Security fund.
- 93. We support the replacement of the current Social Security system with new private and voluntary retirement plans
