I have cosponsored a number of measures, including the No Taxpayer Funding of Abortion Act (S. 582) and the Child Interstate Notification Act (S. 404), relating to human life. Most recently, I joined Senator Lindsey Graham in introducing the Pain-Capable Unborn Child Protection Act (S. 1553). Earlier this year, I voted in support of a procedural motion that would have allowed for Senate consideration of a House-passed companion measure to S. 1553, but it was six votes short of the 60 needed to override a minority filibuster.

The question of whether or not abortions should be permitted within the United States has divided our country for many years. It engenders strong passions among Americans because the problem brings into conflict competing values on the nature of life and society. There are disagreements, but they are differences of opinion between men and women of good will. My hope is that we can continue to have a rational discussion on the merits.

Your involvement in this issue is important. I will certainly keep your thoughts in mind as the Senate considers new legislation in the 114th Congress. Let's keep in touch.
