### **Review responsibilities of the Central Committee:**

Every power of the Kossuth County GOP is vested in the Central Committee. The Executive Committee officers serve at the will of the Central Committee and all their duties and responsibilities are determined by the Central Committee. However, the Central Committee is bound by Iowa law and the Constitution and Bylaws of the Iowa Republican Party, as well as the

Constitution and Bylaws of the Kossuth County GOP. Central Committee members can be removed and replaced by a vote of the Central Committee as specified in the Constitution and Bylaws. Vacant Central Committee positions may be filled by a vote of the Central Committee, as specified. Iowa law (43.100, 43.101) specifies certain things about Central Committees and their officers. Officers to be elected are Chair, Co-Chair, Secretary, and Treasurer.

**February meeting:** There will not be a meeting in February.

The next meeting will be **March 27<sup>th</sup> during the General meeting we will be having an election of officers which include Chair, CO-Chair, Secretary, and Treasurer.**

**Though the Chair is to be voted on Wendell Steven has voiced his interest in remaining Chair.**

**All Central Committee members are encouraged to attend as elections are one of the requirements to being of the Central Committee.**

**Discussion of the U.S. Constitution:** The group discussed the Constitution and understanding how it affects the world around us; how we could explore resources to provide and teach this to individuals in the community. It was mentioned that the Republican Headquarters aka The Daily Grind could be used as a resources to have educational forums.
